

Maternal, Infant, and Early Childhood Home Visiting (MIECHV) Program Grant Awards

MIECHV funding consists of base funds and matching funds, should awardees choose to apply for federal matching funds. HRSA allocates base and matching funds according to the formulas defined in statute. All ceilings reflect the most current information regarding sequestration. In FY 2026, base and matching appropriations for MIECHV are reduced by 5.7% due to sequestration.

HRSA calculates **federal base funding ceiling amounts** according to each state or jurisdiction’s share of children under the age of 5. This is the base funding amount up to which states can apply for. As specified in statute, HRSA uses the most recent U.S. Census data available before FY23 to determine this share.

Matching funds have been available since FY24, with increasing amounts through FY27. HRSA calculates the **federal matching funding ceiling amounts** based on each state or jurisdiction’s share of children under 5 whose families have incomes below the [federal poverty level](#). HRSA uses the most recent U.S. Census data at the time the calculation is made to determine this share.

Since FY25, awardees have been able to apply for additional matching funds. These funds include any matching funds that HRSA did not distribute to awardees in the previous fiscal year, as well as any matching funds that were not used by awardees in prior fiscal years and were returned to HRSA. Awardees have the option of applying for matching funds and additional matching funds but are not required to do so.

MIECHV eligibility is limited to current grantees that have been informed of their base and matching ceilings.
